

# QUESTIONS AND ANSWERS REGARDING FIREARM PURCHASE

**QUESTION: CAN I PURCHASE A FIREARM EVEN THOUGH I AM OUT OF THE COUNTRY OR OUTSIDE MANILA.**

ANSWER: Yes J

**QUESTION: HOW IS THIS DONE?**

ANSWER: We require valid IDs and photos from you to verify your identity and we assist obtaining all the other requirements for you such as clearances and the like to support your firearm application. For more information on this process please read below.

**QUESTION: WHAT ARE THE REQUIREMENTS I NEED TO PROVIDE FOR THE FIREARM LICENSE**

ANSWER: These are the requirements you need to provide for purchasing firearm:

- Two (2) Valid Philippine Photo IDs such as Drivers License, Passport, SSS ID, GSIS ID, Postal ID, OFW/POEA ID, BIR T.I.N. ID or any photo ID issued by a Philippine Government Department or Agency.
- 6 pieces 2x2 ID photo.
- A Completed Personal Data Sheet (a blank copy is attached below which you can use)

**QUESTION: DO I NEED TO SEND THESE VIA POST OR COURIER?**

ANSWER: You can send by post or courier but you can also scan the IDs, 2x2 photo and the completed and signed personal data sheet and email these to us. We then will print these and submit with the other requirements for your firearm application/s.

**QUESTION: HOW DO I PAY FOR THE TRANSACTION?**

ANSWER: You can remit payment into our bank account however if you are not comfortable doing this you can send someone to make payment at our Manila or Pasig branch.

**QUESTION: DO I HAVE TO MAKE FULL PAYMENT WHEN I PURCHASE THE FIREARM?**

ANSWER: Full payment is preferable but you can also make a deposit for us to start the processing of your firearm license so that your firearm can be released from our storage area at Camp Crame. The balance is payable upon the approval of the license which takes between 7-10 working days. Customers who make full payment for the firearm and license are entitled to a free Eagletac waist gun bag or shoulder pouch.

**QUESTION: DO YOU SHIP TO DESTINATIONS OUTSIDE OF MANILA?**

ANSWER: Yes we do. We send our goods airport to airport via Cebu Pacific and we also insure this for your protection. A minimal cost is payable for this service. A permit to transport issued by the PNP always accompanies the shipment so that there is no problem when collection of the firearm is made. You can also nominate another adult to collect the firearm for you. Just write us a letter authorizing another adult to collect your firearm on your behalf and we will indicate this on the permit to transport.

**QUESTION: CAN WE STILL BUY FIREARMS DURING THE COMELEC GUN BAN?**

ANSWER: Yes. The ban is on carrying of guns, not buying guns J . We get the necessary Comelec exemptions to get your firearms to you.

**QUESTION: IS IT SAFE PURCHASING FROM AQUILA? HOW SURE AM I THAT I WILL NOT BE SCAMMED.**

ANSWER: We have been a licensed firearms and ammunitions dealer and a member of AFAD, the Association of Firearms and Ammunition Dealers of the Philippines since 2004.
